A Member who is entitled to attend and cast two or more votes at the meeting may appoint up to two proxies to attend and vote on behalf of that Member.

A Member is entitled to instruct his, her or its proxy to vote in favour of or against any proposed resolutions. Unless otherwise instructed, the proxy may vote as he or she thinks fit.

A proxy need not be a Member of the Company.
