Please consider hiring a car if convenient, appropriate and cheaper). Billeting a judge to save on motel expenses MUST be discussed with the judge prior to acceptance. Meal expenses during the event are covered by the judge's daily per diem. The Convenor agrees to promptly approve reimbursement of agreed expenses to the judge as soon as possible after receipt of claim form together with relevant supporting documents.</p>
