Notes:

Most transactions can be conducted on-line via eAlpaca. If a Member requires the office staff to perform a transaction which could be completed on-line, a surcharge of 5% will apply, and no bulk discounts or early bird fees will be available

1. Bulk registration discounts are applied automatically in eAlpaca based on the total number of cria registered in a financial year (combined total of Female plus Active Male registrations) to each herd prefix. An Active Male is a fully registered male alpaca, identified with an IAR tag, which can be shown, transferred or certified. Inactive Males, Wethers and Females registered over the age of 24 months will not count towards this tally. Bulk registration discounts do not apply for registrations submitted to the office for manual input
2. Inactive Males cannot be shown, transferred or certified; nor can they be identified with an IAR ear tag. This class of registration is primarily for males likely to be sold as pets, guards or for meat. An Inactive Male can be upgraded to Active Male status on payment of the relevant registration fee at any age.
3. Wether is primarily intended for those who wish to enter animals in the Wether classes of AAA shows. Wethers can be identified with an IAR tag and may be transferred to a new owner on payment of the relevant transfer fee.
4. If a transfer is reversed within 12 months of the date of sale then no additional fee will apply. After 12 months the reversal will be considered a new transaction and a further transfer fee will apply.
5. Limited to one transfer per alpaca in each 12-month period
